If you already have a web login and password, please confirm with our sales department that it has remained the same. We will continue to provide this program to you company year after year unless Kirkwood is notified of cancellation. Rates subject to change each season.

The following outlines the details of the partnership:

Kirkwood will provide:

- Web account login specific to your company.
- Trail Maps, winter brochures upon request.
- Kirkwood logo for your web site upon request
- Banner ads, HTML's, promo cards and posters to promote this offer.

Kirkwood Partner will provide:

- Distribution of your web login to employees via email, newsletter, or any other form of advertising.
- Discounted Season Passes (rates subject to change) lift tickets to your employees at \$58.00. Full ticket rate for the season is \$78.00. Meaning your customers/employees save over \$18.00 per ticket.
